**The Legends Golf Program Enrollment Application and Agreement**

I, \_\_\_\_\_, a current member of the Missouri Athletic Club (the "MAC"), desire to enroll in the MAC-sponsored golf program with The Country Club at The Legends (the "Country Club"). In registering for this program, I understand and agree to the following:

1. The fee (the "Golf Overlay") is \$250.00 per month, which will be billed to my MAC member account each month. Any partial month in which I am enrolled in the program shall be treated as a complete month and, accordingly, I agree to pay the full Golf Overlay for any partial month in which I am enrolled.
2. My commitment to pay the monthly Golf Overlay and rights to enjoy membership privileges at the Country Club shall begin on the later of June 1, 2007 or the Effective Date written by me below, and shall continue until May 31, 2008. Provided, however, I understand and acknowledge that if the underlying agreement between the MAC and the Country Club is terminated at any time prior to May 31, 2008, my commitment shall terminate concurrently and I will have no further rights to use the Country Club by virtue of the MAC-sponsored golf program at any time after such termination. In the event the underlying agreement between the MAC and the Country Club is extended beyond May 31, 2008, I will have the opportunity to re-enroll in the program on the same terms and conditions as set forth in this Application and Agreement.
3. My commitment to pay the monthly Golf Overlay will terminate if I cease to be a member of the MAC for any reason or take an official MAC membership leave of absence.
4. My enrollment in this program provides my immediate family (e.g., spouse and children under 21 years of age) and me with the right to enjoy full membership privileges at the Country Club, including without limitation, unlimited rounds of golf, use of a locker, use of the driving range, use of the dining facilities, participation in the Country Club's discount pro shop plan, and other amenities which are normally afforded to full-privilege members of the Country Club.
5. I agree to conform to and be bound by the Bylaws and all rules and regulations of the Country Club while on the Country Club's property.
6. I may invite guests to play golf with me or a member of my immediate family at the Country Club at standard guest rates, and all guests will also be subject the Country Club's Bylaws and all rules and regulations while on the Country Club's property.
7. Any purchases of guest rounds, or other goods and services which I make at the Country Club, with the exception of food and beverages, may be paid for by me using a credit card or I may sign my name and MAC membership number and have the MAC bill me for any purchases on my monthly MAC statement. I agree to pay any such charges and the monthly Golf Overlay in accordance with the MAC's normal billing policies, and I acknowledge that late payments for the Golf Overlay and any charges incurred by me at the Country Club shall be subject to the MAC's normal late fees and enforcement actions, including suspension and termination of my MAC membership if I do not remit payment within the time allowed pursuant to the MAC's normal billing policies.
